## Terms of Reference

---

### Objective

The Commission on the Integration of Refugees has been convened by the Woolf Institute, Cambridge, to:

- Investigate how the current UK refugee and asylum system<sup>1</sup> impacts integration outcomes.
- Assess the effectiveness of integration-focused services across the UK (in terms of housing, education, health care, social services and access to employment), and compare practices across the country.
- Explore refugees' and asylum seekers' experiences of the UK refugee and asylum system and integration-focused services.
- Understand how the wider UK general public and civil society perceives and interacts with refugees and asylum seekers, especially at a local level.
- Propose evidence-based changes to the UK refugee and asylum system to ensure the meaningful integration of refugees which respects their rights and commands support from diverse stakeholders with contrasting views.
- Provide and compare economic modelling for the costs of the current and newly proposed UK refugee and asylum system in so far as they affect integration outcomes.

<sup>1</sup> Refugee and asylum system' refers to all those aspects of UK law, governance and society pertaining to those seeking protection in the UK, including the asylum system; resettlement schemes; phased and ad hoc visa schemes, such as those for British Nationals (Overseas) in Hong Kong or Homes for Ukraine; and the local government and third sector agencies involved in the integration of people seeking protection. 'Refugee' refers to any person who has sought or is seeking sanctuary in the UK, including those currently going through the asylum system; granted asylum; resettled via a government backed resettlement scheme; and granted permanent or temporary leave to remain following visa adjustments for BN(O) and Ukrainian residents.

## Meetings of the Commission

Commissioners will participate in five all-day meetings and seven Local Engagement Hearings around the UK from September 2022 to December 2023. A pre-commission day event was held on 15 June 2022 to discuss a preliminary schedule of themes and issues to be discussed at these meetings.

## Local Engagement hearings

There will be six city hearings – in Birmingham, Manchester, Croydon, Newcastle, Glasgow and Cardiff – and one rural hearing. Each will be organised locally. At each hearing, the Chair or Vice-Chair will be accompanied by 3–4 Commissioners.

The Commission will invite individuals and organisations to the hearings to give evidence, engage in discussion and air views. The hearings will be by private invitation. The Commission will seek to hear from a broad range of views, including those seeking protection, academics, employers, health care professionals, faith leaders and politicians.

## Public Call for Evidence

The Commission will issue a general call for evidence in early 2023 from individuals and organisations. All evidence taken from the hearings and the public call will be considered by the Commission when compiling its final report.

## Visits

The Commission will visit locations which play a role in the asylum system or in providing integration support for refugees, such as refugee accommodation and charity drop-in sessions.

## Reporting

The commission will issue its report with recommendations in late 2023. The report will be accompanied by webinars and media activity to disseminate its findings.

## Funding

The commission is funded by the Woolf Institute.
